# Self-Driven Boats Terms & Cons.

## Booking Terms & Cons -

The Booking deposit of €50 paid before the day of rental is only refunded back to the client due to bad sea conditions (rough sea force 4-5) on the day of rental. The clients will be contacted if the weather is not safe to go out at sea and will be given the opportunity to change the booking to a different day with better sea conditions.

#### Renal Terms & Cons -

Before departure, at the place of hire (Xlendi Bay) the designated driver will be asked to present a form of ID or Passport in order to fill up an "agreement form". This form states the driver's details, accommodation, the rental details: duration, departure & return time, the cost of rental, insurance excess information and all conditions applicable such as:

- 1. Clients are to drive at the slowest speed possible in and out of any bay or harbour.
- 2. Drivers are to keep 50 meters away from any other craft (boat).
- 3. Clients are to exceed 10 knots only when driven outside the bay and at least 300 meters away from the shore.
- 4. Clients are not allowed to enter in any bays where an indication of yellow and orange markers placed by the Transport Malta to reserved the area as a swimming zone.
- 5. Destination of hire is only allowed one mile off the coast of Gozo and Comino.
- 6. Destination of hire is only allowed around Gozo and Comino.
- 7. Powered crafts are only allowed to be driven by persons over the age of 18 years.
- 8. If client is seen to be in a wreckless or unsafe manner or racing with any other craft, the Operator has to immediately terminate the ride and this has to be made very clear to all prospective clients.
- 9. All persons using the facilities are to wear a life jacket.
- 10. Persons driving the boat are not allowed to drink alcohol or use any narcotics.
- 11. Xlendi Water Sports & staff are not responsible for any loss of hirer personal belongings or any physical injuries to the hirer, guests and others.
- Prices are exclusive of fuel. Fuel supplied at local rates, and consumption is measured at
  the end of the rental. All boats come equipped with all EU safety equipment, cushions,
  and open canopies. License to drive boats under 100Hp is not required but some
  experience is compulsory. The designated driver must take responsible care of the boats
  and equipment obeying all local laws and shall be solely responsible for their passengers
  and belongings.
- Anything which is broken or lost during the rental time and doesn't exceed the Insurance Excess limit, listed in the agreement form has to be evaluated and paid for right away at the end of rental.

- The designated driver must take responsible care of the jet ski and equipment, obeying all local laws and shall be solely responsible for their passengers and belongings.
- Anything which is broken or lost during the rental time and doesn't exceed the Insurance Excess limit, listed in the agreement form has to be evaluated and paid for right away at the end of rental.
